A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
KITSAP CONSERVATION DISTRICT, KITSAP COUNTY,  
WASHINGTON, ESTABLISHING THE 2024 ELECTION AND  
APPOINTMENT OF THE BOARD OF SUPERVISORS.

WHEREAS, the three-year term of Albert Allpress who holds elected Position #1 on the Board of Supervisors of the Kitsap Conservation District, will expire in May of 2024; and

WHEREAS, the appointment of Chris Benson, who holds the appointed Position #5 on the Board of Supervisors of the Kitsap Conservation District, will expire in May of 2024; and

BE IT RESOLVED by the Board of Supervisors of the Kitsap Conservation District, Kitsap County, Washington, as follows:

Section 1. The Kitsap Conservation District Board of Supervisors election will be held on Tuesday, March 26, 2024.

Section 2. Ballots will be available to eligible voters through digital access beginning March 5, 2024, at 8:00 a.m. Deadline for voting is March 26, 2024. Voters that require accommodation to vote may call 360-204-5529 ext. 113 or e-mail [j-garrit@kitsapcd.org](mailto:j-garrit@kitsapcd.org). Those requiring a paper ballot on election day, may vote at our office, Kitsap Conservation District, 10332 Central Valley Rd. NE, Poulsbo, WA 98370 in person between the hours of 10 AM and 2 PM. Votes will be counted March 29, 2024, at 2 PM. No other drop boxes are being offered for Kitsap Conservation District ballots.

Section 3. The deadline for candidate filing for Position #1 on the Kitsap Conservation District Board of Supervisors is February 20, 2024, at noon (12:00 PM). Applications should be returned to Kitsap Conservation District, 10332 Central Valley Rd. NE, Poulsbo, WA 98370. Any candidate statements must be included with the filing application and are limited to 200 words. Section 4. The appointment filing window for Position #5 is March 1, 2024 to March 31, 2024. Appointed positions are filled by the Washington State Conservation Commission.
